CALL FOR PAPERS

The journal therefore calls for papers for publication in its maiden edition. Manuscripts submitted for publication in JBPA are considered on the understanding that they are not being considered for publication elsewhere and have not been published. The publisher of JBPA does not accept responsibility for accuracy of the contents as opinions expressed in articles published by JBPA are solely those of the author(s).

Articles intended for publication in JBPA may be submitted online, preferably in Microsoft Word (2003 or 2007) format. Submissions may also be sent by post and in such cases three copies of the article should be sent to the address stated below.

Prospective author(s) should adhere strictly to the **guidelines** hereunder:

- (i) Paper should be original in content and of good quality;
- (ii) Paper to contain an abstract of not more than 250 words;
- (iii) The main text: font is 12-point typed in Times New Roman; not more than 8000 words (including all elements, abstract and references); double-line spacing
- (iv) The recommended style of referencing is the American Psychological Association (APA) 6th edition;
- (v) Paper submitted should contain the following information: short and informative title, name of author(s), and institutional affiliation and email address of the contributor;
- (vi) Author(s) should arrange their names such that the family/surname comes last

- (vii) Paper submitted for publication should not have been submitted for assessment or publication elsewhere;
- (viii) Authors to include in the paper a short Biography; and
- (ix) Tables and figures must be numbered, titled and sources provided.
